Re: Presentation House Gallery Feasibility Planning – File: 6740-20 FL-01 / 7780-20 PHG-01

Mr. Reid Shier, Director/Curator, Presentation House Gallery and Ms. Cheryl Stevens, President, Board of Directors, Presentation House Galley, gave a presentation regarding "Presentation House Gallery Feasibility Planning", as follows:

- the Presentation House Gallery is a respected cultural contributor to life on the North Shore;
- the Gallery's world-class reputation has been established despite a substandard deteriorating facility;
- following the completion of a Strategic Plan in 2009, the Gallery identified and re-established the Foot of Lonsdale Avenue as its preferred location;
- in the fall of 2010, the North Shore Arts Office completed the Lower Lonsdale Cultural Facilities Study, confirming the Foot of Lonsdale as an ideal location for the Gallery;
- with the permission of the Washington Marine Group and support from the City, Presentation House Gallery began a preliminary structural and program analysis of Cates Building this past spring;
- the building incorporates an ambitious and idiosyncratic steel structure that could be retained while allowing for an architecturally interesting retrofit, with the potential of becoming an iconic attraction for North Vancouver;
- two small annex buildings adjoin the main facility. The building to the west sits on land owned by Washington Marine Group while the north building, together with the main facility, is on land owned by the City;
- preliminary cost estimates to retrofit the existing Facility in proportion with the Gallery's needs is \$4.9 Million, to rebuild a new north addition is \$1.4 Million and these two projects could be phased;
- the total construction cost of both buildings with contingency is approximately \$7.9 Million;
- with soft costs and outfitting, total project costs at the highest standard for a new home for Presentation House Gallery are \$9.5 Million;
