 the society's Mission is to build a harmonious and inclusive North Shore community that assists immigrants and refugees to integrate successfully into life in Canada;

- the society's role as a not for profit organization is to provide services and programs that provide information, orientation and referral on Canadian systems to assist new immigrants and refugees to settle in North Shore communities:
- majority of funds are received from federal government;
- · the society does not receive core funding;
- 44 staff members.

## Mr. Aghay spoke regarding:

- his experience as a recent immigrant to Canada two years ago who was lucky to find the society and to enroll in their employment program;
- noted that the growth in population in the City over the past 25 years has largely been immigrants;
- 34 percent of the North Shore population are immigrants;
- the three major challenges for immigrants are learning English, finding jobs and understanding the Canadian culture and traditions;
- innovative programs geared to youth, seniors, women but if funding is not received, some of these programs will have to be discontinued.

## Ms. MacDonald spoke regarding:

- the challenges in obtaining a suitable rental facility that is in an accessible location and has enough space;
- difficulty in obtaining long leases;
- the society's wish to partner with the City to investigate opportunities for subsidized rental space in future developments.

Ms. Jones and Ms. MacDonald then responded to questions from members of Council.
