Ms. Sue Lakes-Cook, Resident, City of North Vancouver, gave a presentation regarding "City of North Vancouver Budget", as follows:

- lives in the lower Lonsdale area, which is considered one of the poorest per capita areas in the GVRD;
- has been studying budget of City of North Vancouver employees and alarmed to see bridge between average person earning \$45,000 and the budgeted salaries of City of North Vancouver;
- 146 employees earning between \$75,000 and \$254,189 totaling \$31 million dollars, however, there are total of 480 employees so there are at least 300 employees whose salaries are not reflected in the overall budget;
- requested the total amount of salaries for all employees in the City of North Vancouver and would like to know why she can't have this information;

Ms. Sue Lakes-Cook, Resident, City of North Vancouver - Continued

- \$344,306.60 in expenses requested to know what the breakdown of expenses are for listed in the budget;
- has found employees of the Library earning over \$75,000, not included in with other staff;
- concerned with salaries of Fire Department staff and questioned need for the number of Fire Department staff for a city the size of North Vancouver;
- requested total of salaries for Fire Department and was told information was not routinely available;
- agree with amalgamation of the three North Shore Fire Departments;
- understand that the City of North Vancouver Fire Department does not support amalgamation of North Shore fire services and would like to know why not and would like to know Council's opinion of amalgamation of the North Shore fire services:
- 150 sitting mayor and councillors were asked to sign a pledge to keep property taxes low; asked how many City Councillors have signed the pledge;
- urged renters and owners to get out and vote for independent candidates who will stand up for their rights;
- Would like answers to her questions and would like to know why she hasn't been given answers to her questions.
