Councillor Clark inquired of Mayor Mussatto when Council would be considering these bylaws.

23. Recreation Commission Meeting Regarding Reduced Attendance at Harry Jerome

Inquiry by: Councillor P.J. Bookham

Councillor Bookham referred to a recent North Vancouver Recreation Commission meeting at which attendance figures were provided that indicated attendance at Harry Jerome was dropping significantly. She inquired of Mayor Mussatto whether Council Commission members knew why this was.

Councillor Fearnley suggested that the documents provided at that meeting be provided to Council. He advised that a number of factors were cited at the meeting for decreased attendance, including increasing operating costs for the older building, decreased revenues, competition from new recreation facility in West Vancouver and budget issues in the District of North Vancouver.

Councillor Clark indicated that reduced attendance is occurring in other recreation facilities as well as Harry Jerome and advised that the meeting referred to where this issue was discussed was a Finance Meeting of the North Vancouver Recreation Commission and that a recommendation from that meeting would first need to go to a public North Vancouver Recreation Commission meeting.
