Ms. Jean Macintyre and Ms. Sheila Paterson, Residents of North Vancouver, made a presentation regarding "Foreign Trade Zones and Comprehensive Economic and Trade Agreement (CETA)", as follows:

- first heard about the Foreign Trade Zones (FTZ) being planned by both the Provincial and Federal governments for Deltaport and later for other areas in BC in May of this year;
- FTZ involve 100% foreign ownership;
- disregard of labour standards resulting in what amounts to sweat shops;
- little or no local labour;
- no tax revenue for local governments;
- no environmental standards;
- Helps trade and business but not families;
- Port expansion will result in potential doubling of container capacity at Deltaport which will adversely affect Fraser Estuary, one of the most significant bird sanctuaries;
- in the launch of her jobs plan, Premier Clark mentioned international trade zone;
- Delta agricultural land will be affected; sale of BC Rail; Tsawwassen treaty process; port expansion;
- first step is to get community aware of what is going on;
- FTZ subject to labour, health, environmental and immigration laws;
- Canada is about to sign a Comprehensive Economic and Trade Agreement (CETA)with the European Union;
- this trade agreement has been done behind closed doors:
- Canada's public health care system is at risk from big corporations in Europe if the agreement goes through;
- for the first time ever in a Canadian trade agreement, water services are on the table;
- the local government could lose control of water management in North Vancouver;
- if water utilities become covered under procurement chapter of the agreement, big companies will be able to come here and bid for contracts which will result in costly dispute process as private water companies could then challenge municipalities' decisions on award of water services contracts:
- need to have a Memorandum of Understanding that trade exempts water;

- there hasn't been any discussion in municipalities about these two agreements;
- Council of Canadians is the best body to consult on this issue.
