4. City Wide Phase 2 Geotechnical Stability Study – File: 5280-17-02

Report: Manager, Engineering Planning & Design, December 23, 2011

The City Clerk read into the record the following resolution of the Committee of the Whole in camera which was ratified by Council on January 9, 2012.

"PURSUANT to the report of the Manager, Engineering Planning & Design, dated December 23, 2011, entitled "City Wide Phase 2 Geotechnical Stability Study":

THAT copies of the report entitled "Phase 2 Geotechnical Stability Study – Detailed Risk Analysis" dated December 2011 as prepared by GES Geotech Inc. (the Study) be provided to the affected property owners;

AND THAT all affected property owners be encouraged to implement the recommendations specific to their property as identified in the Study with those having an assessed specific risk of "high" or greater be strongly encouraged to implement measures that, in the opinion of a qualified professional engineer, reduce the respective risk to "moderate" or lower, as defined in the Study;

AND THAT the City provide the following assistance to the affected property owners:

- 1. any municipal permit fees associated with implementing these requirements be waived by the City;
- subject to the cooperation of affected property owners that the City fund and coordinate a detailed investigation of onsite drainage conditions and develop drainage improvement plans for individual property owners;
- 3. provide project coordination assistance to help implement the recommendations provided in the Study; and
- 4. seek potential sources of funding from senior levels of government to mitigate impacts to property owners

AND THAT the City work with the owners of the Cypress Gardens complex to develop a plan for the stabilization of the adjacent creek bank on City land giving consideration to "Stabilization Works" that are available as a Local Area Service;

AND THAT any further costs associated with the design and implementation of the recommended remediation strategies on private lands be the responsibility of the respective property owners;

AND THAT a copy of this resolution be forwarded to the local Provincial MLA and local Federal MP;

AND THAT the recommendation and the report entitled "Phase 2 Geotechnical Stability Study Detailed Risk Analysis" dated December 2011, remain in-camera for one week while staff attempt to notify the affected property owners regarding the Study;
