Pan-Municipal Affairs Service Establishment Bylaw - File:0400-60 MV-01

Presentation: Mr. Johnny Carline, Commissioner and Chief Administrative

Officer, Metro Vancouver.

Mr. Johnny Carline, Commissioner and Chief Administrative Officer, Metro Vancouver, gave a presentation to Council regarding "Pan-Municipal Affairs Service Establishment Bylaw", as follows:

- Regional District has often been a forum to discuss issues of common concern, for example port properties in lieu of taxation issue, ports development plans and future policing in municipalities;
- the chair at the time established subcommittees to facilitate those types of discussions;
- went out to the community with a sustainability summit, community indicated they didn't want the Regional District to expand its services but wanted the Regional District to continue hosting and facilitating public discussions of regional issues of common interest;
- looked at whether the Regional District could do this work within its existing mandates;
- it was determined it would be safer to establish a service establishment bylaw to legitimize those activities and would be more transparent and accountable;
- municipalities that wish to participate in this service must approve the Pan-Municipal Affairs Service Establishment Bylaw.

Mr. Carline then responded to guestions from members of Council.

Ms. Gwen Elliott, Resident, City of North Vancouver.

Requested by City Council on November 28, 2011.

Re: East 29th Street Speed and Pedestrian Review – File: 8330-01

Ms. Gwen Elliott, Resident, City of North Vancouver, gave a presentation regarding "East 29th Street Speed and Pedestrian Review", as follows:

- extended thanks for traffic improvements to date on E. 29th;
- met with engineering staff before Christmas;
- meeting was very constructive with excellent suggestions for improvements;
- referred to suggested improvements outlined in staff report;
- to increase safety, the neighbours' preference would be to have full green and red light at the intersection of St. George's and E. 29th, as there is the potential for cars to run a flashing light;
- staff indicted that kind of light signal would be activated too infrequently and that pedestrians will just cross anyway so it wouldn't be effective;
- contrary to staff's assertion, she feels there are no sufficient gaps in traffic for safe crossing;
- issues on 29th: poor visibility, speeding, no crosswalks, effects of the hill on traffic speed and patterns, road rage, difficulties parking and using driveways, emergency response vehicles;
- preference is for option that will provide greatest safety for pedestrians;
- supports additional corner bulge at the St. George's intersection South West corner, noting this was where she and her daughter were almost hit;
- to address concerns regarding speeding from St. George's up to the hill and coming down, her preference would be for a zebra crosswalk or at the very least a bulge at one of the two north corners of St. Mary's, which would give more visibility, cars would have to slow down, would provide increased safety for pedestrians after getting off bus;
- these issues need to be addressed as soon as possible;
- is City willing to pay for and assume responsibility for these improvements if the District agrees but cannot contribute funding;
- her delegation is willing to approach District of North Vancouver to request they contribute funding for these improvements.

- located at 14th and Rufus;
- had unique set of challenges when they broke ground in the spring;
- ground breaking Feb 26, 2011 with 70 people in attendance;
- community's enthusiasm for and involvement in the project are significant reasons for success of this project;
- with strength of volunteers, 98 fence post holes dug by hand in a day;
- soil moved onto site:
- hundreds of yards of organic matter moved onto site;
- by April first seedlings sprouted;
- grand opening of site April, 2011 with150 people attending throughout the day;
- have been able to support 3 part time employees;
- added benefit, organic waste diversion;
- substantial transformation of the site in a few short months;
- soil takes time to build;
- is a wet site, so it is a challenge;
- held 37 produce sale days;
- sold over \$3,500 worth of produce in the first season;
- thanks to those who provided financial support;
- goals for 2012: improving signage on the site, more public awareness, enhance education opportunities, double farm production, diversify crops, double farm gate sales, consider addition of honeybees and other pollinators.
