- Outdoor dance is major fundraiser for the festival with proceeds funding scholarships, seniors' activities and providing seed money for following year's festival;
- Shipbuilder's Square ideal new location for the Caribbean Days Festival;
- This is the 25th year the festival has been held in the City;
- Staff's request to terminate outdoor dance at 10:00 p.m. due to noise concerns would result in economic loss to the festival;
- The only noise is music, not rowdiness;
- Festival provides social and economic value to the city;
- The festival has helped to make North Vancouver a tourist destination:
- Requested dance be allowed to proceed until 1:00 p.m.
- Thanked city staff for their work with festival organizers;
- The festival organizers have always worked with staff to address any concerns so they don't occur in subsequent years;
- \$300,000 cost to hold festival, 75 80% of which is funded through year round volunteer fundraising efforts;
- A deficit of between \$5,000 to \$10,000 is projected for this year's festival due to additional 25th anniversary special events;
- Volunteers getting older, adjustments had to be made;
- Dance subsidizes cost of festival:
- Asking City to grant use of Shipbuilder's Square for the event, provide one time additional grant of \$5,000 to defray costs of 25th year festival and refrain from billing for additional costs that may be incurred during this year's festival.

- 1. The Federal Government is closing the Kitsilano Coast Guard search and rescue station;
- 2. The station serves the busiest port in Canada, and responds to 300-350 search and rescue calls a year;
- 3. The consolidation of rescue services at the Sea Island hovercraft base will be 17 nautical miles farther away from its current location;
- 4. There was no public consultation on the closure, and the City of North Vancouver had no advance warning of the closure;
- 5. The closure of the Kitsilano Coast Guard search and rescue station is another marine safety service for North Vancouver being eliminated by the Federal Government, along with the recently announced closure of the coast guard communications centre in Vancouver, and the BC command centre for emergency oil spills;
- 6. Any response to increased risk to marine public safety due to Federal cutbacks may be borne by the City's first responders;

- 1. The Mayor, on behalf of the City of North Vancouver, write to the Federal Government expressing the City's opposition to these closures, and urge the Federal Government to reverse them;
- Staff report back on the full range of safety and financial impacts, including increased service demands on City first responders, as a result of the Kitsilano Coast Guard station closure and any other Federal marine safety cutbacks.
