#### **BYLAWS - Second and Third Readings**

1. "City of North Vancouver Official Community Plan Bylaw, 2002, No. 7425, Amendment Bylaw, 2012, No. 8269" (Onni Group, IBI Group, 1308 Lonsdale Avenue / 130 East 13<sup>th</sup> Street / 117-133 East 14<sup>th</sup> Street, Height Amendment to Figure 1.Potential Maximum Building Heights in High Density Areas).

"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2012, No. 8268" (Onni Group, IBI Group, 1308 Lonsdale Avenue / 130 East 13<sup>th</sup> Street / 117-133 East 14<sup>th</sup> Street, CD-631).

**THAT** Bylaw No. 8268 be read a second time in short form.

Moved by Councillor Bell, seconded by Councillor Buchanan

**THAT** Bylaw No. 8268 be amended as follows:

- A new subsection be added to the CD-631 Zone after subsection 3 (16):
  - "(17) One driveway shall be permitted from 13<sup>th</sup> Street with a maximum width of 14.6 m (48 ft.) or as otherwise approved by the City Engineer";
- Schedule 101 entitled 'Building Labels and Setbacks' is hereby deleted in its entirety and replaced with the new Schedule 101 attached to the February 21, 2013 Information Report of the Director of Community Development entitled "Development Application: 1308 Lonsdale (ONNI, 1308 Lonsdale Holdings Ltd./IBI/HB Architects) Public Hearing #2 Update", with the further revision to increase the easterly podium setback from 15 ft. to 30 ft.
