- 1) The total amount of the principal of the loan is not to exceed \$12 million;
- With the exception of an amount of \$500,000 to be provided to LEC for cash flow reserve purposes, funding received under the loan is to be used for the sole purpose of building LEC's distribution network;

AND THAT Lonsdale Energy Corp. provide an annual report on the balance and payments of principal and interest of the loan, as well as on construction activities impacting borrowing and loan repayment.
