- Metro Vancouver Naval Monument Society, be responsible for all expenses associated with the design, fabrication and installation of the sculpture;
- Final Design/configuration of the sculpture including revisions to the stance of the female worker and confirmation of historic accuracy be approved by the North Vancouver Public Art Advisory Committee prior to fabrication;
- 3) City staff, Public Art Officer and Metro Vancouver Naval Monument Society work together to find a suitable location for the sculpture on the Shipyards site, once Council adopts a plan for the Shipyards site.
