1. "Official Community Plan Bylaw, 2014, No. 8400" (A Bylaw to Establish a New Official Community Plan)

**THAT** second reading of "Official Community Plan Bylaw, 2014, No. 8400" (A Bylaw to Establish a New Official Community Plan), be rescinded.

## BYLAW - RESCIND SECOND READING AND AMEND

2. "Official Community Plan Bylaw, 2014, No. 8400" (A Bylaw to Establish a New Official Community Plan)

Moved by Councillor Keating, seconded by Councillor Buchanan

**THAT** "Official Community Plan Bylaw, 2014, No. 8400" (A Bylaw to Establish a New Official Community Plan), be amended as follows:

- 1. Delete Section 2.8.1 "Lucas Centre Special Study Area" and Section 2.8.2 "Cloverley Special Study Area" in their entirety and renumber the remaining sections accordingly;
- Amend Schedule A Land Use Map, by deleting the Lucas Centre Special Study Area boundary and Cloverley Special Study Area Boundary;
- 3. Amend the map in Figure 7 Frequent Transit Development Areas by deleting the Cloverley Special Study Area Boundary.

Add a new section immediately following Section 2.8.6 "Site 8 Special Study Area" entitled "1301-1333 Lonsdale Avenue Special Study Area" and renumber the sections accordingly;

### "1301-1333 Lonsdale Avenue Special Study Area

This site's location at the southern extent of the Central Lonsdale City Centre core makes it visually important in defining the City Centre. This study would consider the possibility of an increased maximum building height at this location."

3. "Official Community Plan Bylaw, 2014, No. 8400" (A Bylaw to Establish a New Official Community Plan) – Continued

Amend Schedule A - Land Use Map, by adding a Special Study Area boundary to 1301 - 1333 Lonsdale Avenue (Lot 3, Block 62, D.548/549 Plan14958 and Lot 1, Block 62, D.548/549 Plan 14011).

**THAT** the Queensbury Special Study Area boundary on Schedule A - Land Use Map, be amended to include the lands on the east side of Queensbury Avenue as far south as and including 819 East 3rd Street, 250 Queensbury Avenue, 802 East 3rd Street and 808 East 3rd Street.
