**AND WHEREAS** the City of North Vancouver's Official Community Plan (2015), Climate Adaptation Plan (2013) and Community Energy and Emissions Plan (2010) provide a strong policy foundation supporting a healthy environment;

**AND WHEREAS** the City of North Vancouver recognizes that our world and all of its inhabitants are faced with the growing and increasingly urgent impacts of climate change, air and water pollution, and loss of biodiversity;

The City of North Vancouver declares that:

- 1. All people should have the right to live in a healthy environment, including the right to:
  - breathe clean air;
  - drink and access clean water;
  - consume safe and healthy food;
  - access nature;
  - know about pollutants and contaminants released into the local environment; and
  - participate in decision-making that will affect the environment.
- 2. Within its jurisdiction, the City of North Vancouver has certain authority respecting the protection of the natural environment and public health. The City of North Vancouver will consider applying the precautionary principle: where concerns respecting public health or the natural environment may exist, the City of North Vancouver will consider measures within its jurisdiction and authority to address such concerns.
