19. City of North Vancouver Water Consumption

Moved by Councillor Bell, seconded by Councillor Keating

WHEREAS the Friday, July 17, 2015 Vancouver Sun newspaper front page story suggests that while "Water use is down sharply across most of Metro Vancouver over the last decade", the City of North Vancouver has the worst record of the three Metro Vancouver municipalities reported showing increases; and,

WHEREAS the reported total drop in water consumption for Metro Vancouver is reported as a nine percent decline over a nine year period; the figure for the City of North Vancouver is reported as an increase of 16%; and

WHEREAS the per capita water consumption for Metro Vancouver is reported as a decrease of 20% over the same period; the figure for the City of North Vancouver is reported as an increase of 3.9%; and,

WHEREAS the issue of municipal water management and consumption has been highlighted during the current period of severe drought conditions for Metro Vancouver municipalities, causing water consumption reduction regulations to be implemented throughout the region; and,

WHEREAS the City of North Vancouver should examine the possible causes for the increase in water consumption and undertake appropriate corrective action wherever possible;

THEREFORE BE IT RESOLVED THAT City staff be asked to investigate and prepare a report for Council as to the reasons for the reported City of North Vancouver water consumption figures to be so high an increase compared with the rest of the Metro Vancouver region, which shows a decline in water consumption, and to recommend possible actions the City can take to remedy this disparity.
