THAT Council support the submission of the following resolution to the Union of British Columbia Municipalities (UBCM) for consideration at the September 26-30, 2016 UBCM convention:

WHEREAS cycling has become an integral part of municipal transportation systems across the Province of British Columbia and an important method for reducing community greenhouse gas emissions;

WHEREAS electric bicycles have become increasingly popular for their capacity to support people from a range of ages and abilities to incorporate cycling into their daily activities;

AND WHEREAS PST exemptions are already in place for standard bicycles, transportation fares, as well as financial incentives for clean energy vehicle purchases;

NOW THEREFORE BE IT RESOLVED THAT UBCM urge the Province of British Columbia to reinstate the PST exemption for electric bicycles to help ensure the environmental and health benefits of cycling are accessible to a wider range of British Columbians.
