"Retail-Service Group 1-A Use" means a Use providing for the sale at retail or repair of household or personal goods or things, or for extending services to persons; includes Child Care Use, grocery stores, bakery shops, meat and fish markets, supermarkets, delicatessens, drug stores, clothing stores, personal furnishings shops, hardwares, variety stores, department stores, book shops, toy stores, home furnishing and appliance stores, camera shops, stationery stores, barbers, hairdressers, tailors, shoemakers, launderettes, dry cleaners, printers, trade and business schools, appliance repairs, restaurants and cafes, coffee houses, dance and music studios, art galleries, social clubs, health clubs, billiard halls, fraternal lodges, bowling alleys, theatres, veterinary clinics and internet cafes; but excludes an Accessory Drive-Through Use, Bingo or Casino Gaming, an Escort Service Use and all licensed Premises except Food Primary Licence, unless expressly provided for in this Bylaw, as defined under the regulations pursuant to the Liquor Control and Licensing Act, and any single retail use occupying an area larger than 3,710 square metres (40,000 square feet) established in the City after March 15, 2000."

**THAT** Council support the submission of the following resolution to the Union of British Columbia Municipalities (UBCM) for consideration at the September 26-30, 2016 UBCM convention:

**WHEREAS** 1 in 8 men in British Columbia will be diagnosed with prostate cancer in their lifetime representing the number one cancer risk to men;

**AND WHEREAS** the economic, family and social costs to our province would be significantly diminished through increased awareness and early detection;

**NOW THEREFORE BE IT RESOLVED THAT** UBCM request the provincial government make PSA testing free for all men in the province to ensure all men have the opportunity to have prostate cancer diagnosed as early as possible so that survival and quality of life will be improved;

**AND THAT** UBCM and its constituent members declare September to be Prostate Cancer Awareness Month.

## 16. North Shore Rescue / BC Ambulance Service (BCAS) Responders – File: 01-0230-20-0045/2016

**WHEREAS** the North Shore Rescue (NSR) Team has been vital in keeping our North Shore Mountains safe for residents and visitors alike;

**WHEREAS** the NSR has been directly responsible for the saving of lives in our wilderness areas that are owned and managed by various entities, including the local municipalities, Metro Vancouver and the Provincial Government, who all benefit from the actions of NSR;

**WHEREAS** there is a longstanding tradition and policy by the BC Ambulance Service (BCAS) set up by the late team leader of NSR and Unit Chief of the North Vancouver Ambulance Station of the BCAS, Tim Jones, to respond when NSR has to respond to identified medical emergencies;

**WHEREAS** current members of NSR who work for BCAS and while on duty for BCAS have been allowed to respond when medical emergencies have been confirmed and emergency medical treatment is required;

**AND WHEREAS** this procedure has recently been halted by BCAS;

**NOW THEREFORE BE IT RESOLVED THAT** the City of North Vancouver work with the District of North Vancouver and the District of West Vancouver to demand the very important and lifesaving policy of allowing existing members of NSR to respond when actively working for BCAS be reinstated;

**AND THAT** a meeting be set up as soon as possible with our local MLAs to discuss this situation and, if necessary, arrange a meeting with the Minister of Health and the Premier of BC to continue the lifesaving practice recently halted by BCAS.
