THAT staff be directed to prepare Zoning and Business Licence Bylaw amendments to enable a staff review and approval process for child care facilities with capacities up to 12 spaces in residential zones and that all other applications will be referred to the current Business Licence review process;

THAT applications with any of the following conditions be referred to Council for review:

(a) Where the proposed facility is situated on a property that is under 5,900 square feet in area; or

(b) Where the proposed facility is situated on a block where there are one or more existing group child care facilities on the same block, or on an adjacent block separated by a lane; or

(c) Where the required on-site parking is directly accessed from a collector or arterial road;

THAT the Business Licence application process for group child care facilities in residential zones be amended to seek Council's initial consideration and referral to Public Meetings;

AND THAT the maximum number of children in care as an Accessory Use in a residential zone be reduced from 17 spaces to 16 spaces.

CARRIED UNANIMOUSLY

THAT applications which include the operation of a Principal Use Facility be referred to Council for review.
